Regulation (EU) 2017/2403 Of The European Parliament and of the Council, 2017

Purpose

To inform Ship-Owners/ Managers/ Operators, Registration Officers (RegOffs), Recognised Organisations (ROs) about the forbidden activities / operations related to the transportation of fish or fishery products.

Application

1. As per the Food and Agriculture Organization of the United Nations / Fisheries and Aquaculture Department any ship, boat or other type of vessel used, equipped to be used or designed to be used for fishing and fishing related activities as any operation in support of, or in preparation for, fishing, including the landing, packaging, processing, transshipping or transporting of fish that have not been previously landed at a port, as well as the provisioning of personnel must comply with the requirements of a fishing vessel and guidelines of UN.
2. International instruments / regulations against illegal fishing:
 - a. *United Nations Convention on the Law of the Sea, 1982 (UNCLOS)*; provides the international legal basis for the protection and use of living and non-living resources of the world's oceans.
 - b. *Food and Agriculture Organization of the United Nations*; plays a leading role in international fisheries policy.

- c. *1993 FAO Compliance Agreement*; aims to enhance the role of flag states to ensure that none of their vessels are fishing on the high seas, unless authorized.
 - d. *1995 UN Fish Stocks Agreement*; aims to ensure the long-term conservation and sustainable use of straddling and highly migratory fish stocks within the framework of UNCLOS.
 - e. *International Plan of Action to Prevent, Deter and Eliminate Illegal, Unreported and Unregulated Fishing (IPOA-IUU)*; focus on all State responsibilities, flag State responsibilities, coastal State measures, port State measures, internationally agreed market-related measures, research and regional fisheries management organizations.
 - f. *Agreement on Port State Measures (PSMA), 2016*; first international binding agreement to prevent, deter and eliminate illegal, unreported, and unregulated fishing (IUU) which is against national laws and international obligations.
 - g. *Regulation (EU) 2017/2403 Of the European Parliament and of the Council, 2017*; concerning sustainable management of external fishing fleets
3. Ship-Owners / Managers / Operators / Charterers, Registration Officers (RegOffs), Recognised Organisations (ROs), Masters, Crew members are discouraged to participate in the transportation of fish or fishery products or participate in activities in support of fishing operations.
 4. In light of the above, this Administration hereby **prohibits** all Sierra Leonean vessels from engaging in any operation in support of, or in preparation for, fishing, including the landing, packaging, processing, transshipping or transporting of fish and fishery products as well as the provisioning of personnel, fuel, gear and other supplies at sea outside the EEZ of Sierra Leone.
 5. Should any Sierra Leonean Vessel engage in any of the operations mentioned above, this will result to her **immediate removal from the Registry** and imposition of a fine as per Maritime Circular No.11.
